If e-mail is used, it would be best to download the AAA's submission forms from their website (http://www.aaanet.org) and to send us the completed forms as a word-processed e-mail attachment (but please do not use Word Perfect!). However, data may be submitted as a plain email file, and the program committee will make sure that the data submitted is entered on the correct AAA forms before these are sent to the AAA on April 1, retyping and formatting as necessary. However, please note that members who submit abstracts to the SSILA program committee by fax or e-mail must still make arrangements to pay the AAA's advance registration fees. Since this can be done by credit card, we recommend faxing the advance registration form to us with the credit card data completed. #### Mis-identifying the colonized

A colleague has asked for one or two references dealing with indigenous peoples of the Americas that would help him document how colonizers tend to mis-identify the colonized. Peter Wells is a well-known archaeologist who studies "Iron-Age" cultures of Europe, particularly the ancient "German" tribes. The ethnic labels used by Caesar, Tacitus and other early chroniclers tend to be accepted without question by those who use their works today. His own researches indicate that the complex cultural divisions that existed in ancient times are inaccurately reflected in the exogenous ethnic designations.

I told him about the naming problems that arose when Europeans attempted to record the various cultures and languages of the Americas, and how indigenous peoples are now attempting to reclaim names and identities that were largely excluded from the history books. He knew what I was talking about because he had already read Berkhofer, and had assigned some of his writings in a course. I mentioned the "synonymy" sections in the <u>Handbook of North American Indians</u> that appear at the end of chapters on individual tribes, but I was wondering whether readers of the SSILA Bulletin might know of a more general discussion of this problem, such as for Central Mexico where pejorative names used by Tlaxcalans and Aztecs names were imposed on neighboring groups by the Spanish. I know the common linguistic folklore about this phenomenon, but can anyone suggest specific articles or books?

# 106.2 INDIAN LANGUAGES TO BE INCORPORATED INTO COMPUTER GAME

Heriberto Avelino (avelino@ucla.edu) writes us that, a few weeks ago, he received a series of messages from some computer-game developers in Los Angeles who are working on an update of "Age of Empires II", an "educational, historical CD-ROM computer game." Marketed by Microsoft, this enormously popular "real-time strategy" game combines "stunning graphics" with the "drama and intrigue" of world history from the Fall of Rome through the Middle Ages. According to the game's official website:

...players are challenged to build their nations into great civilizations and defeat the enemy by making strategic decisions throughout the game. Each of the 13 civilizations represented in "Age of Empires II," including the Mongols, Celts, Vikings and Japanese, features distinctive attributes, buildings and technologies and a unique combat unit based on its historical counterpart.

In addition, "Age of Empires II" features five campaigns based on the adventures of prominent historical figures, including Joan of Arc, William Wallace and Ghengis Khan, that draw players deeper into the game as they march alongside the hero to victory. In the update that is being prepared, two New World civilizations are being added to the roster: The Aztec Empire and the Classical Maya. Heriberto was contacted to see if he would be interested in recording dialogue in Nahuatl. The developers explained:

Single word statements and commands will occur when the player clicks on a villager, priest, military man or king (one set each for the various cultures). The client is anxious that the pronunciations be historically and linguistically accurate. They are providing us translations with phonetic spellings. That means that, in the case of Nahuatl, it will be Classical Nahuatl that would be spoken. [We think] it important that people native to the country in general, and familiar with Nahuatl specifically (even if it's only the "modern" version) be utilized for the speaking parts, because that would greatly increase our chances of correct pronunciations. We need one woman and two men for each language. We will have each man do two speaking parts in varying "voices." Each person would have about twenty (or less) single and double word phrases to utter.

Heriberto turned the job down because he felt that it was not right for a company like Microsoft to use contemporary cultures and languages in combat games. To him, this is far from being an "educational" or "historic" tool. Doubtless, however, the forces of commodification will prevail, and hordes of adolescent gamers around the world will soon be (electronically) crying "Die, vile scum!" in Classical Nahuatl as they hurl their virtual spears at the enemy. (One wonders if the parameters of the game allow for the defeat of Cortez?)

Lest you think this is a small matter, either culturally or commercially, Microsoft has so far shipped over two million copies of "Age of Empires II", and it sells at a retail price of \$54.95.

## **106.3 UPCOMING MEETINGS**

#### Maya Meetings at Texas (Austin, March 9-18)

The 2000 Maya Meetings at Texas will be held March 9-18 on the campus of the University of Texas at Austin. The theme this year will be CENTERING THE UNIVERSE: Core/Periphery Interactions in Mesoamerica.

The Maya Meetings at Texas is a 10-day conference held annually since 1977 (usually the first or second week in March). While retaining the name "Maya Meeting", the conference now encompasses many areas and ancient cultures of Mesoamerica, and other parts of Native America.

The Meetings will open with the XVIIth Texas Symposium, March 9-10. The Symposium brings together scholars and interested non-professionals to interact creatively and share the most recent insights on and discoveries in Maya and Mesoamerican research. Papers will be presented by Edwin Barnhart, Federico Fahsen, Antonia Foias, Christopher Jones, Grant Jones, Richard Hansen, Peter Harrison, Patricia McAnany, Alfonso Morales, Juan Antonio Valdes, Phil Wanyerka, and others.

The core of the Maya Meetings comprises:

- I. Introducing Maya Glyphs: An introductory public lecture by Peter Mathews of the University of Calgary, on March 10.
- II. The XXIII Linda Schele Forum on Maya Hieroglyphic Writing, March 11-12. This year's Forum, "Tikal and Its Neighbors: 600 years of Maya History viewed from the center of the Maya Universe" will be presented Nikolai Grube and Simon Martin. The forum will begin with basic, introductory concepts of Maya writing, and proceed by degrees to analysis of the most complex and enigmatic texts.
- III. The XVIIIth Long Workshops will be held March 13-18. The Workshops are divided into a Maya hieroglyphic workshop, a Mixtec codices workshop, and advanced seminar groups. Topics for individual workshop groups vary from year to year. First time attendees will participate in a group in either the Maya or Mixtec workshop at a level corresponding to their experience. Admittance to advanced seminar groups is by application. The Long Workshops will be conducted by an experienced team of experts on Mayan epigraphy and related disciplines. Under the general direction of Professor Tom Jones of Humboldt State University, the workshops are designed to provide practical experience in the analytical methods discussed in the Forum.
- IV. Maya and Advanced Seminar Groups. Each year special groups are formed to investigate the texts, history, and the role of gods and ancestors at various sites. In addition, Kathryn Josserand and Nicholas Hopkins offer a workshop on Classic Maya and Modern Chol Grammar. Ruth Krochock will head groups working on Chichen Itza and other Yucatecan sites. Rex Koontz will organize a group on Xochicalco. Justin Kerr leads a group on Maya Ceramic Texts. Richard Johnson heads a group investigating the Dresden Codex. A workshop lead by Barbara MacLeod and Robert Wald continues research on

Verbs in the inscriptions. John Justeson and Terry Kaufman lead groups on Zapotec Glyphs and the Epi-Olmec La Mojarra Script. Final topics to be announced.

V. The Mixtec Codex Workshop will continue with Director John Pohl and Assistant Director Robert Williams, with the assistance of Timothy Allbright and Monica Bellas. The workshop is open to all; no prior experience is required.
